Sustaining One's Ongoing Professional Development List of Possible Journals to Follow

The following is a beginning list of possible journals and publications to follow to help support your ongoing professional development (PD). In general, instructors should seek continuing PD in at least the following areas: 1) your content/disciplinary area; 2) general education theories and practices; and 3) discipline-specific educational theories and practices (e.g., science education, nursing education, etc.). If one is working at a mission-centered institution, then your PD should also include journals and organizations who are involved in mission-related issues both in education as well as in your discipline. In addition, as technology is becoming an increasing part of society and education, one's continual learning should include resources that can help to keep you up-to-date on educational technologies. The annotated list below is therefore intended to help you to get started with each of these areas.
